- It has also been charged by the Lambeth Conference to study and evaluate Muslim-Christian relations and report regularly to the Anglican Consultative Council

NIFCON work. His time has been divided between this work and a post at Lambeth Palace where he has been working in support of the interfaith work of the Archbishop of Canterbury. Rana has come to us on an internship for three years, funded by the Lambeth Partners, from the Church of Pakistan. He competes his term at the end of November 2012. Rana has made a great contribution to the Communion's interfaith work during the time he has been with NIFCON. He has contributed to enlarging our horizons and deepening our understandings, especially through his lived experience in Pakistan.

# International, interfaith dialogues al-Azhar

For a number of years NIFCON has administered the dialogue between the Anglican Church and the Permanent Committee of al-Azhar al-Sharif for Dialogue with Monotheistic Religions in accordance with the agreement to maintain ongoing dialogue signed in 2002. The mosque of al-Azhar in Cairo, Egypt, dates back to 969 BCE (358 AH) and has grown over the centuries not only to include a university but to become the premier Sunni world centre for Islamic studies.

**2010 Dialogue in Cairo** focused on the important role religious leaders have in using their influence to promote religious harmony, particularly in countries where there is religious diversity. The meeting also discussed the need to ensure the welfare of all religious minorities wherever located and to safeguard their right to freedom of religion and freedom of worship. **2011 Dialogue in London** Unfortunately it was not possible for this meeting to proceed in the planned form. The Egyptian delegation was unable to leave Cairo due to the political instability of the time. The Anglican delegates, however, met and were able to take stock of the dialogue. Thanks were expressed to Bishop Alexander Malik, Church of Pakistan, for his leadership of the Anglican delegation and best wishes for his retirement in 2012. Bishop Mouneer Anis accepted the Archbishop of Canterbury's invitation to take over the co-chairmanship from Bishop Malik.

**2012 Dialogue in Cairo** (proposed) This meeting is planned for late November. We hope to explore together understandings of citizenship and community. Anglican members of the 2012 Delegation are The Rt Revd Mouneer Anis, Bishop of Egypt (Anglican Co-Chair); The Most Revd Datuk Bolly Lampok (Primate of SE Asia, Bishop of Kuching); Professor Yvonne Haddad, Professor of the History of Islam and Christian-Muslim Relationships, Georgetown University Washington) and the Rt Revd Jonathan Frost, Bishop of Southampton (England).

## Anglican-Jewish Commission meeting Oxford 2012

The Commission's mandate is taken from the provisions of the joint declaration of the Archbishop and the Chief Rabbis made at Lambeth Palace on 6th September 2006 and confirmed at their subsequent meeting in Jerusalem. The 2012 theme of the Commission's meeting was 'Religion and Democracy' in each tradition.

Christian Muslim Digest http://nifcon.anglicancommunion.org/digest/index.cfm

Published electronically four times per year this offers a digest of information from English-language newspapers and broadcast services in the main countries or areas where Anglicans and Muslims regularly encounter one another. It seeks to provide factual coverage of stories involving Anglicans and Muslims in a way that shows a) what is happening in relations, and b) how the stories are handled in the media. In addition to this, there are occasional detailed reports about a particular area, adding to factual coverage some analysis and opinions from as wide and authoritative a selection of commentators as possible.

Land of Promise: an Anglican Exploration of Christian Attitudes to the Holy Land, with special reference to Christian Zionism

This piece of work was undertaken at the request of ACC-14. It explores the doctrine of Christian Zionism as it impacts the life of our churches, in particular attitudes to Israel Palestine and the Christian communities there. (a separate agenda item at ACC-15) This document is included in the papers for the ACC-15 meeting.

Generous Love: the truth of the Gospel and the call to dialogue - an Anglican theology of interfaith relations

Demand for this publication continues, as does use of the online study guide <a href="http://www.aco.org.books">http://www.aco.org.books</a>. The study guide is designed to be updated and developed so that the stories and articles, prayers and weblinks can be added to reflect insights from different parts of the Communion. ## **CONFERENCES AND VISITORS**

#### **Presence of Faith Symposium**

A sympsosium for a group of theologians, in December 2011, to review and discuss Anglican involvement in Christian dialogue and encounter with other faiths, and also to remember and celebrate the immense contribution of Bishop Kenneth Cragg to this field of Christian endeavour.

The main themes covered in the papers were:

The history of Anglican involvement in other faiths over the last 100 years:

Theological reflection on the motivation for this involvement and assessment of it;

The lived experience and involvement of Anglicans present and past in various parts of the world in relation to other faiths.

**Regional Consultations** an opportunity to bring together participants from a particular region to focus on a specific interfaith concern.
