I. DELEGATE COUNTRY REPORT FORM

In 2010, the 54th Commission on the Status of Women will review the implementation of the Beijing Declaration and Platform for Action (BPfA) and the outcomes of the twenty-third special session of the General Assembly. It will also review the contribution of the BPfA to shaping a gender perspective towards the full realization of the Millennium Development Goals (MDGs).

The Anglican Observer at the United Nations, Hellen Grace Akwii-Wangusa, has requested that all Provincial Delegates attending the CSW:

- 1. Educate themselves on the overall objectives of the Beijing Platform for Action (BPfA) and the Millennium Development Goals (MDGs).
- 2. Deepen their understanding of the Anglican theological perspective on the issues raised in the Beijing Platform.
- 3. Equip themselves to present requests, progress reports, and outcomes on the implementation of the BPfA and the MDGs to various U.N. bodies and Non-Governmental Organizations.
- 4. Advocate effectively on these concerns to high-ranking representatives of their National Government and Anglican Church.
- 5. Build the capacity to support grass roots Mission work on this and related issues by Anglican Churches throughout the Communion by listening to concerns, challenges, and best practices presented by other delegates.

Each Provincial Delegate is also to compile a performance/progress Country Report following the guidelines below.

COUNTRY REPORT GUIDELINES:

- 1. Select One (1) of the 12 Critical Issues of the BPfA and its related MDG/Targets and Indicators (*if applicable*) and research and document the advances and obstacles that your home country has faced in the implementation of its objectives.
- 2. We strongly recommend that you take the time to review all 12 critical issues of the BPfA and its related MDG/Targets and Indicators before choosing one to report. This approach will be advantageous when broad discussion takes place.
- 3. The report must be 5 (minimum) to 7 (maximum) pages and written in Times New Roman font, 12pt size, and single-spaced. Avoid any repetitions; the report should be concise and to the point.
- 4. Ensure you properly cite all sources used for your report.
- 5. In addition to the Country Report, write a 1 page summary outlining in bullet points the key findings of your report. This one page summary should serve as a handout that will supplement your seven-minute presentation (explained below).

COUNTRY REPORT DATA SOURCES:

In order to prepare your report, you will need to collect relevant information on your nation's government policy and progress on <u>ONE</u> BPfA Critical Issue. Since there have already been 5- and 10-year assessments of the progress on BPfA, please focus only on statistics and data for your Critical Issue and the related MDG, Target and Indicators for the period from <u>2005-2010</u>. You may gather your information from:

- 1. The government or official country report. These are available online but you can also get them from Ministry of Gender/Women and other ministries especially Finance, Foreign Affairs, Health, Education, Trade and Economic Planning.
- 2. The "Overview of Beijing Platform for Action and Resources" (*Section III of this Packet*) and the "Millennium Development Goals, Targets and Indicators" (*Section IV*); as well as other BPfA and MDG articles, websites and print resources.
- 3. National Bureau of Statistics

- 4. Your Provincial Department for Development, Women's and Family Work,
- 5. Non-Government Organizations and other Faith Based organizations including the Ecumenical organizations.
- 6. Embassies (some will provide more current and accurate information than others)
- 7. Anglican provincial and diocesan development departments and other Church institutions and resources
- 8. UN agencies (such as UNIFEM, UNICEF, UNDP, UNFPA have thorough web-sites)
- 9. Other Internet Sites (make sure they are reputable)
- 10.Independent Research of your own, <u>most especially any possible interviews with</u> women and men who attended the original Beijing Conference in 1995.

3. Describe the country's/ region's current situation in regards to the Critical Issue and related MDG, Targets and Indicators (if applicable).

PART II: GOVERNMENT POLICIES/RESPONSES

- 1. What is the government policy of your country/region on the BPfA and MDGs?
- 2. Using the MDG Targets and Indicators (*if applicable*) related to your BPfA Critical Issue:
 - ➤ What efforts, *if any*, has the government been taking to develop laws or policies to meet the Targets and/or address the BPfA Critical Issue?
 - ➤ What progress, *if any*, is reflected in the statistical data on the Critical Issue/MDG Target for the period 2005 2010.

PART III: SUCCESSES & CHALLENGES

- 1. Describe three positive and practical activities/outcomes that have been proven effective in the government effort to address the Critical Issue/MDG.
- 2. Describe three challenges that hinder any type of progress from being made.

PART IV: RECOMMENDATIONS

1. What recommendations do you suggest for government and civil society in regard to your findings above?

PART V: FAITH PERSPECTIVE

- 2. The oral report must not exceed seven minutes. (The written report may be longer, but due to time restrictions, oral reports must keep to time for us to complete the training agenda).

Lastly, you are expected to read and become familiar with the resources pertaining to the Beijing Platform for Action and The Millennium Development Goals found in Section III and Section IV of this packet.

II. GUIDELINES FOR ADVOCACY AND LOBBYING NATIONAL GOVERNMENTS

Based On Your Country Report Research:

• Have a strong command of the specific statistics and facts under your selected BPfA Critical Issue (and related MDG/Targets and Indicators, *if any*) that you will need to understand and refer to when advocating for change.

Since you are a delegate of the Anglican Communion, know who you are representing when approaching your home government officials:

- Locally: How many Christians in your diocese?
- Globally: The Anglican Communion has 80 million members in 44 regional and national member churches around the globe in over 160 countries.
- As Christians, you should also have a deep theological perspective on the chosen issue.

Be clear what the Anglican Communion has said on these issues already and from where you derive your mandate:

- Resolutions of The Anglican Consultative Council. (*Note especially Resolution 31 of the ACC13 Nottingham 2005*) http://www.anglicancommunion.org/communion/acc/meetings/index.cfm)
- The Five Marks of Mission (the last three of which relate directly to the BPfA and MDGs)
 - 1. To proclaim the Good News of the Kingdom
 - **2.** To teach, baptize and nurture new believers
 - 3. To respond to human need by loving service
 - 4. To seek to transform unjust structures of society
 - 5. To strive to safeguard the integrity of creation and sustain and renew the life of the earth

Shape the relevant Country Report data on government policies and progress on your Critical Issue/MDG in the format and the language understood by governments:

- You must use the language of goals, targets and indicators
- Analysis of the issue must be relevant and up to date
- Develop a theological rationale for critiquing or supporting the current government policy
- Find out who else is lobbying for this issue and decide whether to connect with them

Develop concrete proposals clearly outlining what you propose as an alternative:

• Be clear and specific about what you want to be changed.

Identify to whom you are going to present this:

Which national group is able to make decisions? Remember it is usually civil service, the technocrats, who craft policy.

III. OVERVIEW OF BEIJING PLATFORM FOR ACTION AND RESOURCES

In September 1995 the United Nations convened the Fourth World Conference on Women in Beijing, China. At this conference – which focused on action for equality, development and peace – 189 member governments adopted the Beijing Declaration (BD) and Beijing Platform for Action (BPFA). More than 5,000 women and men representing international NGOs also endorsed the outcomes of Beijing.

Considered the most comprehensive agenda for the advancement and empowerment of women, the BFPA aimed at accelerating the implementation of the Nairobi Forward Looking Strategies - devised a decade earlier in 1985 - in order to achieve greater equality and opportunity for women to realize their full potential and human rights.

The BPFA contains strategic objectives and actions on 12 Critical Issues:

- > Women and Poverty
- > Education and Training of Women
- **➤** Women and Health
- **➤** Violence against Women
- Women and Armed Conflict
- Women and the Economy
- **➤** Women in Power and Decision-making
- > Institutional Mechanisms for the Advancement of Women
- **➤ Human Rights of Women**
- > Women and the Media
- Women and the Environment
- ➤ The Girl-child

The Beijing conference signaled a clear commitment to achieving the norms and standards of equality between men and women as they are articulated in international instruments like the Convention on the Elimination of all forms of Discrimination Against Women (CEDAW). There was a strong call for actions and measures undertaken by governments and other actors at the international, regional, national and local levels to especially focus on the urgent need to protect and promote the rights of women and the girl child.

It was also noted in the BPFA that deeply entrenched attitudes and practices perpetuate inequality and discrimination against women in public and private life in all parts of the world. The platform emphasized that the full implementation of the BPFA can only be realized if the values, attitudes, practices and priorities that inform development programs and initiatives are also transformed. Accordingly, the BPFA underscored the urgency for reorienting the way institutions work (in terms of their values and cultures – both formal and informal – as well as the practices) in order to expedite implementation at all levels. Most importantly, BPFA provided tools for women to work with to change their own situation.

In 2000 and 2005 the first and second reviews of progress were undertaken (the Beijing +5 review and the Beijing +10 review) to assess the level of implementation and identify any emerging issues and obstacles that may hinder the full implementation of the BPFA.

The 2000 review process took place at a very opportune moment as gender and women's rights advocates were able to influence the millennium development agenda adopted then in form of the Millennium Development Goals (MDGs). In the Millennium Declaration the 189 member states of the UN undertook to advance a global vision for improving the conditions of humanity in the areas of development and poverty eradication, peace and security, protection of the environment, and human rights and democracy. The absolute necessity of advancing the human rights of all people in order to achieve this vision was underscored. In particular, the advancement of gender equality was recognized as critically necessary if any significant progress was to be realized. Member states explicitly pledged to combat all forms of violence against women and to implement CEDAW.

What was most profound was the recognition that the promotion of gender equality and women's empowerment are central to all efforts aiming to combat poverty, hunger and disease and stimulating truly sustainable development, and thus the member states reaffirmed their commitment to implement the outcomes of the 1990s UN conferences, including the 1995 Beijing Conference on Women.

IV. MILLENNIUM DEVELOPMENT GOALS (MDGs) TARGETS AND INDICATORS

The Millennium Development framework of 8 GOALS was tied to 18 TARGETS in order to define explicit markers of achievement. The targets were further complemented by 48 TECHNICAL INDICATORS to provide statistical data measures towards the MDGs and indicate the agreed-upon data source for the statistics. These Indicators have since been adopted by a consensus of experts from the United Nations, IMF, OECD and the World Bank.



Goal 1: Eradicate Extreme Hunger and Poverty

TARGET 1. Halve, between 1990 and 2015, the proportion of people whose income is less than \$1 a day

INDICATORS

- 1. Proportion of population below \$1 (1993 PPP) per day (World Bank)
- 2. Poverty gap ratio [incidence x depth of poverty] (World Bank)
- 3. Share of poorest quintile in national consumption (World Bank)

TARGET 2. Halve, between 1990 and 2015, the proportion of people who suffer from hunger **INDICATORS**

- 4. Prevalence of underweight children under five years of age (UNICEF-WHO)
- 5. Proportion of population below minimum level of dietary energy consumption (FAO)



Goal 2: Achieve Universal Primary Education

TARGET 3. Ensure that, by 2015, children everywhere, boys and girls alike, will be able to complete a full course of primary schooling

INDICATORS

- 6. Net enrolment ratio in primary education (UNESCO)
- 7. Proportion of pupils starting grade 1 who reach grade 5 (UNESCO)
- 8. Literacy rate of 15-24 year-olds (UNESCO)



Goal 3: Promote Gender Equality And Empower Women

TARGET 4. Eliminate gender disparity in primary and secondary education, preferably by 2005, and in all levels of education no later than 2015

The following is a report by the Anglican Observer at the UN, Ms Hellen Wangusa, from one of the Plenary gatherings of the 54th Session of the United Nations Commission on the Status of Women (CSW) regarding the issue of Human Trafficking and Violence against women.

Defining the Challenges of Trafficking and Violence against Women, and Re-defining the Role of the Government and Men

One of the biggest challenges regarding human trafficking and violence against women is related to the conceptual development of what is understood by 'violence' against women- it is often regarded as domestic violence. <u>Violence against women is a</u> developmental issue.

A second challenge is competing for limited and dwindling funding for women's work (UNIFEM), Women's NGOs, and even emerging Men's groups. Challenges in the legislative sector stem from the fact that Feminism has been correlated with the escalation of violence. However, there is still a need for information education and mechanisms for seeking redress. Violence against women is also still widely considered a 'private' issue, thus the state's or government's inability to implement UN and other instruments against it. Therefore, accountability and impunity using due-diligence, UN instruments, and other existing tools (as well as CEDAW) are needed.

Similarly, there is a need for mechanisms and models for collaborating with Police (especially on immigration), and collaboration between men and women against violence and trafficking. For too long we have focused on the supply side, but we need to pay close attention to the *demand* side of trafficking. This is vital to track, monitor, and develop means of rehabilitating trafficked persons.

Lastly, the issue of Gender for Men must be addressed: what makes a man, a man? Many emerging men's groups such as the 'White Ribbon Campaign' and 'Boys for Mothers', are doing good work in revisiting and broadening the framework or understanding of 'masculinity'. These groups work towards making violence against women part of our daily/local conversations. Power, privilege, and hierarchy are a valid entry point for discussing and questioning masculinity. At the same time, it is vital to progress from victimization to empowerment, and to guard against models that put women at risk as a direct consequence of patronage and financial insecurity.
